## Hate Crime in New York State 2012 Annual Report

### Introduction

This report meets the statutory reporting requirements of the Hate Crimes Act of 2000 and details the findings of a statistical analysis of New York State hate crime incidents, arrests and dispositions.

The report is based upon hate crime incidents and arrests that occurred during 2012, and dispositions for those arrests, reported as of August 2013. Data sources analyzed in this report include incident reports submitted by local and state police and arrest and disposition data derived from the Computerized Criminal History (CCH) system at the Division of Criminal Justice Services (DCJS).

The report has three components. The first describes 2012 hate crime incidents reported by law enforcement. Hate crime incidents are detailed by offense, bias motivation and demographic characteristics of known offenders. The second component details arrests made in 2012 for hate crime offenses and the disposition of those arrests through Aug. 21, 2013. (These arrests may not be related to the incidents reported for 2012). The third component is a comparison of hate crime incident data from 2010 through 2012 presented as a series of appendices.

### *Major Findings*

- ◆ A total of 720 hate crime incidents were reported for 2012 in New York State, a 30% increase from 2011. This increase was primarily due to a rise in reported property crimes in Suffolk County and New York City.
- ◆ New York City reported 374 hate crime incidents (up 54.5% from 2011) and 148 hate crime arrests. The Rest of the State reported 331 incidents (up 17.8%) and 138 arrests.
- ◆ Hate crimes against property (409) increased 48.2% in 2012, while hate crimes against persons (311) increased by 11.9%.
- ◆ The most frequently reported bias motivations for hate crimes against property in 2012 were anti-Jewish (64.5%) and anti-Black (13.7%).
- ◆ The most frequently reported bias motivations for hate crimes against persons in 2012 were anti-sexual orientation (26.4%), anti-Black (25.4%) and anti-Jewish (21.9%).
- ◆ Most hate crime incidents involved criminal mischief (53.1%) or simple assault (38.6%).
- ◆ Of the 113 offenders convicted from a hate crime arrest as of Aug. 21, 2013, 31.8% received a jail or prison sentence, and 4.4% were sentenced to probation.

## Reported Hate Crime Incidents

Under New York Penal Law Section 485.05, a person commits a hate crime when one of a specified set of offenses is committed targeting a victim because of a perception or belief about their race, color, national origin, ancestry, gender, religion, religious practice, age, disability or sexual orientation, or when such an act is committed as a result of that type of perception or belief. Hate crimes can be perpetrated against an individual, a group of individuals, or against public or private property. Table 1 shows hate crime incidents reported for 2012 by the type of offense.

- The 720 offenses reported as hate crimes for 2012 represent a tiny fraction of all crimes reported to the police in New York State. In 2012, 451,054 Index crimes – murder and non-negligent manslaughter, forcible rape, robbery, aggravated assault, burglary, larceny and motor vehicle theft – were reported. Also reported last year were thousands of lesser offenses, known as Part II crimes, such as harassment and vandalism.



- Of the 720 total 2012 hate crime incidents reported, 311 (43.2%) involved crimes against persons and 409 (56.8%) were property crimes.
- Simple assault (278) accounted for 89.3% of crimes against persons and 38.6% of all hate crime incidents.

- Criminal mischief (382) accounted for 93.4% of property crimes and 53.1% of all hate crime incidents.
- A total of 720 hate crime incidents were reported for 2012 in New York State, a 30% increase from 2011. This increase was primarily due to a rise in reported property crimes in Suffolk County and New York City

The investigating officer initially identifies an offense as a hate crime and, when reporting, specifies the bias motivation. Figure 1 shows the number of hate crime incidents reported for 2012 by major bias type and shows the percentage of all hate crimes that fall within each category.

Figure 1. Hate Crime Incidents by Bias Type 2012



- For 2012, the most commonly reported types of bias motivation in hate crime incidents were religion (56.3%), race/ethnicity/national origin (29.9%) and sexual orientation (12.9%).
- During 2012, there were 405 hate crime incidents involving religion, a 59.4% increase from 254 in 2011.
- Incidents with a race/ethnicity/national origin bias increased 18.1% in 2012 to 215 as compared to 182 in 2011.
- Incidents with a sexual orientation bias decreased 13.9%, from 108 in 2011 to 93 in 2012.
- Three-year trends for 2010, 2011 and 2012 can be found in Appendix Table 1.

Table 2 shows detailed bias motivation for crimes against persons and property crimes among the 720 total hate crime incidents reported for 2012.

- Anti-Jewish hate crimes accounted for 82% (332) of 405 religious bias incident reports.
- Bias against blacks represented 62.8% (135) of the 215 reported anti-race/ethnicity/national origin hate crimes.
- Of the 93 anti-sexual orientation hate crimes, 74.2% (69) targeted male homosexuals.
- These percentages are similar to prior years.

### **Crimes Against Persons**

- The number of hate crime incidents against persons increased 11.9%, from 278 in 2011 to 311 incidents in 2012.
- Bias against race/ethnicity/national origin was the motivating factor reported in 43.1% (134) of the 311 crimes against persons, sexual orientation bias in 26.4% (82) and religious bias in 28.6% (89).
- Anti-black (79), anti-Jewish (68) and anti-male homosexual (62) crimes were the most frequently reported crimes against persons.
- Within the anti-religion category, Jewish bias accounted for 76.4% (68 of 89 incidents). In 2012, incidents motivated by Islamic bias increased to 18, up four from the previous year.
- Within the anti-race/ethnicity/national origin category, anti-black bias accounted for 59% (79 of 134) of reported hate crime incidents.
- Within the anti-sexual orientation category, male homosexual bias accounted for 75.6% (62 of 82 incidents).

### **Property Crimes**

- Hate crime incidents involving property increased 48.2%, from 276 in 2011 to 409 in 2012.
- Of the 409 reported hate crime incidents involving property crimes, 77.3% (316) were motivated by a bias against religion, up 69% from 187 incidents in 2011.
- Anti-Jewish bias accounted for 83.5% (264 of 316) of reported property hate crimes against religion. Property crimes involving bias against Jews increased by 78.4%, from 148 in 2011 to 264 in 2012.
- Anti-black bias accounted for 13.7% (56) of property hate crime incidents reported for 2012.
- Appendix Table 1 shows three year trends.

## Offenders as Reported by Their Victims

Reporting of offender demographic characteristics by the victim or another party is often incomplete. Offender demographic information was most likely to be missing in crimes that did not involve direct contact between victim and perpetrator, which includes most property crimes.

Table 3 presents the gender, age and race/ethnicity as reported by the victim or other party for the 229 incidents in 2012 in which at least one attribute of offender demographic information was available. A total of 344 offenders were reported; a single incident could have multiple offenders.

- Males comprised 90.7% (312) of the 344 known offenders.
- Age was reported for 203 offenders. Among offenders whose age was known, 60.6% (123) were less than 25 years old.
- Among known offenders, 135 were black, 132 were white and 34 were Hispanic.

For incidents in which the offenders were known, the majority of incidents (72.9%) involved only one offender. Table 4 presents the number of offenders involved in 2012 hate crime incidents.

- Lone offenders accounted for 48.5% (167) of the 344 offenders for whom demographic information was available.
- Two or more offenders were reported in 27.1% (62) incidents, involving a total of 177 offenders. Of these, one incident involved five offenders and 17 involved four offenders.
- Of the 720 total hate crime incidents, 491 involved unknown offenders. Of these incidents, 357 were criminal mischief, 111 were simple assault and nine were larceny.
- Among incidents with unknown offenders, 59.1% (290) were motivated by anti-Jewish bias.

## County of Reported Hate Crime Incidents and Arrests 2012

Table 5 shows that in 2012, 50 of the 62 counties in New York State reported hate crime incidents or arrests. The remaining 12 counties, in which no incidents or arrests were reported, are excluded from the table.<sup>1</sup> Arrest counts represent a hate crime charge being brought at the time of the arrest, as reported by the arresting agency.

- Nine counties reported hate crime arrests in 2012, but no incidents that year. A direct relationship between arrests and incidents in the table should not be drawn; arrests may not be made in connection with some incidents or may occur in different years than the associated incidents.<sup>2</sup>
- Of the 286 hate crime arrests in 2012, 275 were for incidents occurring that year, while nine arrests were for crimes that occurred in 2011. The two other incidents occurred in 2009 and 2010.
- The five counties that comprise New York City — Bronx, Kings, New York, Queens and Richmond — accounted for 51.9% (374 of 720) of all reported hate crime incidents and 51.7% (148 of 286) of all hate crime arrests in 2012.
- Four counties — Suffolk, Nassau, Erie and Westchester — accounted for 74.9% of hate crime incidents and 48% of arrests outside of New York City last year.

## Hate Crime Arrests

Offenses designated as hate crimes are detailed in New York State Penal Law Section 485.05. Table 6 shows the most serious Penal Law offense charged as a hate crime for the 286 arrests made in 2012. In 2012, felony arrests accounted for 68.2% (195) of all arrests for hate crime offenses and misdemeanors 31.8% (91). A hate crime offense was the most serious charge in 87.8% (251) of these arrests.

- The most frequent Penal Law hate crime arrest charges were Aggravated Harassment-2nd (97), a misdemeanor; Assault-2nd (38), a felony; Aggravated Harassment-1st (34), a felony; and Assault-3rd (29), a misdemeanor.

# Hate Crime Dispositions

## Dispositions

As of Aug. 21, 2013, a final disposition had been reported to DCJS for 70.3% (201) of the 286 hate crime arrests occurring during 2012. Dispositions were not available for the remaining 29.7% (85) of the hate crime arrests.

Dispositions for the 201 disposed cases are presented in Table 7.

- Of the 201 reported dispositions, convictions were reported in 140 cases. In all but one of those cases, the conviction to either a felony, misdemeanor or non-criminal violation was the result of a guilty plea.
- In the remaining 61 cases, all but three had a favorable outcome for the defendant.

## Convictions

- Among the 140 convictions, there were 67 convictions for a non-criminal violation, 45 misdemeanor convictions and 27 felony convictions. One case had a missing disposition category, so the outcome is unknown.
- Offenders were convicted of a designated hate crime offense, as specified in Penal Law Section 485.05, in eight of 140 cases.
- When a person is convicted of a hate crime and the specified offense is a misdemeanor or a Class C, D or E felony, the hate crime is deemed to be one class higher—or more serious—than the specified conviction offense. As a result, some of the conviction offenses listed in Table 8 in the felony category are Penal Law misdemeanors elevated to a felony because of the hate crime conviction.

## Sentences for Those Convicted

Sentences reported for convictions from hate crime arrests are shown in Table 9.

- Of the 140 convictions, a conditional discharge was the most common sentence (42), representing 30% of the total.
- Forty-eight of the 140 resulted in a sentence to prison (11) or jail (37), representing 34.3% of the total.
- There were 27 felonies among the 140 convictions. Of those 27, 11 were sentenced to prison, five received sentences of jail or time served, one received probation, none were conditionally discharged and 10 were pending sentence as of Aug. 21, 2013.
