Chautauqua County OWDS and RSW!

Chautaugua County Probation Director, Linda Shields, attended and completed the intense 180 hour OWDS training held in Jamestown. This makes **Director Shields** the first Probation Director in NYS to complete this rigorous training. Jail officials, led by OWDS program manager, Patrick Johnson, warden of the Chautauqua County Jail held their second round of the Offender Workforce Development Specialist training this year, The training, supported by a National Institute of Corrections grant had 29 graduates, and 18 were from the Chautauqua Probation Department.

READY, SET, WORK

Director Shields, wanted to use this program as a way to help her department initiate the Ready, Set, Work! program, a job readiness program for offenders on probation and others with a criminal history. "A lot of the people that we work with don't have the skills, so we want to give them job skills to help them be in a better position," said Shields. "We want to help them overcome barriers to become gainfully employed." Also Director Shields states, "Compliance with probation restrictions doesn't change behavior; giving them (probationers) skills and helping to change the way that they think does."

Cattaraugus County has already begun to implement the Ready, **Set**, **Work!** program and thus far, has seen a very good success rate for their probationers finding and retaining jobs, which reduces the caseload for their probation officers. **Director Shields** also praised the great success that **Albany County** Probation, which originally piloted the program, has had in both offender employment and retention.

On June 27th Cynthia Blair joined the Schenectady County Reentry Taskforce to aive the group information on Pathways to Employment, Ready, Set, Work! and of course OWDS. Wendy Brown. Project Safe Neiahborhoods:

The Governor is awarding \$1 million dollars to six communities - Newburgh, Albany, Schenectady, Brownsville, the Bronx and Manhattan, that are most impacted by gun violence to develop strategies to reduce it. Two prominent academics who have focused on crime and gun violence, Professor Tracey Meares of Yale University and Professor David M. Kennedy of John Jay College, will work with the localities to implement this strategy.. For more information go to


OPCA-DOL Collaboration

Elaine Kost began working with OPCA back in 2003 when the then DPCA approached DOL about how the agencies could collaborate to help stem offender recidivism through employment. OPCA was able to have Elaine's services to visit almost every county in the state and present the Pathways to Employment Program. Elaine traveled to Oklahoma City for the training with the original NYS OWDS team which authored the Ready, Set, Work! Curriculum as their NIC action plan, a required part of the training. The team also authored the **Employment** Matters! curriculum and eventually Retention Counts! and other specialized offender job readiness and retention materials. Elaine was the Federal Bond Coordinator for NYS and she also was known as the "go to" person on anything pertaining to offender employment not only throughout NYS, but nationally as well. Although her DOL duties continued to expand into other arenas she still, as a certified GCDF Instructor, facilitated at least one module every year since the In-State OWDS partnership with NIC began in 2008. Her module was a highlight of the training for many of the participants who gave her glowing reviews. Elaine will be greatly missed but we wish her the best in her future endeavors



Ready, Set, Work! Performance Outcomes

Ready, Set Work is now being held in many counties around the state and is also being looked at for implementation in other areas of the country. As we gather information on the effectiveness of the program we would like to share it with you.

In 2011 OPCA obtained information from 15 agencies, which held a total of **98 RSW!** groups. There were 432 offenders who completed the RSW! groups and 226 of those obtained employment within 90 days. This is a 52% employment rate for 2011. Looking closer at the information, 8 County Probation departments reported holding 25 groups with 175 completers and 105 employed within 90 days, for a 60% employment rate. The other agencies were **Probation Violation** Residential Centers (PVRC) and 200% of Poverty programs. These 8 programs held a total of 73 groups. 257 offenders completed the **RSW!** program and 121 obtained employment, for a 47% employment rate.

Worth highlighting is the **New York City EAC TASC** 200% of poverty program, **Enhanced Employment** Initiative. (EEI). This vocational program is designed to provide court mandated TASC clients with employment placement and other transitional services, enabling defendants and their families to gain financial security and independence. borough provide services

to job seekers whose incomes fall below 200 percent of the federally established poverty level. Program staffs attend an Offender Workforce **Development Specialists** training program sponsored by D CJ S/O P C A, County Probation departments, NYS DOL and the National Institute of Corrections. Alma Sehovic, Program Director and OWDS graduate from the inaugural OPCA class, reports that there were 55 RSW! groups during 2011, 142 participants completed and 83 found jobs. NYC TASC has sent 14 staff to the training since the program began in Albany in 2008. The commitment to changing the lives of those they serve through equipping their staff with the necessary skills is evident. Alma, who has her GCDF, was also a support trainer in Albany for the 2012 training.
