INSTRUCTIONS FOR PREPARING THE AGENCY PERSONNEL REPORT

The Agency Personnel Report is prepared annually and reflects the personnel support of each law enforcement agency as of October 31.

It collects counts of full- and part-time sworn and civilian employees by race, ethnicity, and gender. It requests total agency budget figures. Sheriffs are also asked to report counts of jail, court, and civil-duty employees. As a convenience, the report shown at the tab labeled "Sample Form" illustrates a correctly completed report.

- 1. **Employment Status Summary**. Complete this section using data from section 1^{A,} Personnel Characteristics.
- 1^A **Personnel Characteristics**. All employees should be counted, as either sworn or civilian.
- 2. **Race and Gender**. Select the appropriate race indicator from among the choices of white, black, or other. Note that male, female and gender X employees are to be tallied separately. Gender X is defined as "Unspecified or another gender identity." Ensure that each person is counted under either full- or part-time employment status. Include all employees.
- 3. **Ethnicity**. Ethnicity is not the same as race. All employees have been counted by race in section 2 above. Now all employees will be counted again in the Ethnicity section as either Hispanic or Non-Hispanic. The total number of employees in the Ethnicity section should equal the total number of employees in the Race section.
- 4. **Enforcement Annual Operating Budget**. Enter the Annual Enforcement budget of your agency as of October 31 of the current year. Sheriffs: DO NOT include budget information associated with local correctional facility.

- 5. Correctional Facility Personnel Characteristics. Complete the Race, Gender and Ethnicity tallies, as described in steps 1^A through 3 above, for correctional personnel. For purposes of this form, Deputy Sheriffs in the Correctional Facility section are to be entered only if they are permanently assigned to the jail and their salaries are paid from the corrections budget. Deputy Sheriffs who were counted in sections 1^A through 3 should not be counted again in the Correctional Facility section.
- 6. **Other Assignments**. This section counts employees who are assigned to court or civil duties, without designation of race, gender, full-time status, or ethnicity.
